WAIVER AND RELEASE OF LIABILITY

Welcome to Village West Marina and Resort. We hope your visit at this Resort is as pleasant as possible.

We must point out to you, however, that this resort and the environs around the resort's premises (hereinafter "the Premises") can contain hazards. Hazards that arise or that you might encounter on or around the Premises include, but are not limited to, slips, falls, burns and injuries or damage from falling or dropping objects, electrocution, toxic or noxious fumes, fires, explosions, waves, wind, collisions and sinkings, just to name a few.

Therefore, in recognition of the many hazards that you might encounter while on or around the Premises, which can be in whole or part on or around a navigable water of the San Joaquin Delta, and as a material part of the consideration for entering and using the Premises, you agree to waive, expressly assume the risk of, release and will hold harmless and indemnify the Resort, as well as their agents, employees or contractors for any damages, injury or death to you or your property that may occur for any reason whatsoever as a result of, arising out of, or relating to your presence on in or around the Premises at any time for any reason whatsoever, even if said damage, injury or death occurs solely or partially as a result of negligence of the Resort or their agents, employees or contractors, regardless of the time such negligence may have arisen or occurred.

This release applies to you, your heirs, assigns, successors and guests.

Should the guest wish to be relieved of the effects of this waiver, guest may do so by agreeing to an increased guest fee of 100% that would otherwise be charged to cover the additional potential liability that the Resort may incur, and the insurance that the Resort will have to purchase in order to accept the risk of such potential liability.
